

A maximum of \$5 will be given per semester (July-December and January-June). Report cards for the Fall Semester must be submitted by January 15th; Spring Semester report cards by June 30th. Must maintain a \$100 average balance during the semester to qualify. Must be 16 years or younger at the time of request to qualify and must have a Spark Savings account (S4). All A's paid will be reported as interest income to the IRS.
